## KISS'S "LEDSI THE CROWN TOUR"

### **CONTEST OFFICIAL RULES**

The Station will conduct the **KISS'S LEDSI THE CROWN TOUR** "Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, , age eighteen (18) or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last 30 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the 30 days Void where prohibited by law. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

    On-Air: Listen to the Station weekdays during the Contest Period. When the Station plays the "cueto-call" sounder, listeners must call the Station at (803) 695-5477. Caller number 10 to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win. <u>Time Delay</u>

    Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists

between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by KISS 103.1/WLXC will be deemed not entered in the Contest.

This Contest is in no way sponsored, endorsed, administered by, or associated with KISS 103.1/WLXC's Facebook and Instagram. By submission of an entry, an entrant releases KISS 103.1/WLXC's Facebook [Instagram from any responsibility or liability for the Contest's administration, prizes, or promotion. - 5.
